

## Announcement on the Change of Fund Scheme Amendments of 6 funds

**Aberdeen Asset Management (Thailand) Limited** would like to inform you that we have received an approval from the Office of the Securities and Exchange Commission to amend the Fund Schemes of the following 6 funds;

- (1) abrdn China Gateway Fund (ABCG-M)
- (2) abrdn Japan Opportunities Fund (ABJO)
- (3) abrdn European Sustainable Equity Fund (ABEG)
- (4) abrdn Global Sustainable Equity Fund (ABWOOF)
- (5) abrdn India Growth Fund (ABIG)
- (6) abrdn Global Emerging Growth Fund (ABGEM)

Details of the amendments can be summarized as follows.

1. Changing the name of the mutual funds (ABCG-M and ABJO) to be consistent with the change of the master fund's name.

Old name	New name
abrdn China Gateway Fund	abrdn All China Sustainable Equity Fund
abrdn Japan Opportunities Fund	abrdn Japanese Sustainable Equity Fund

Remark The fund's abbreviation still remains the same.

The amendments to the fund schemes as per No. 1 are effective on 22 April 2022 onwards.

- 2. Updating both master fund's name and investment policy of the following funds as per the Prospectus of the master fund. In addition, the master fund has disclosed sustainability approach in its investment policy as required by Article 8 of the Sustainable Finance Disclosure Regulation (SFDR) and is classified as 'Sustainable Fund', the regulatory measures in the EU for disclosure of the sustainability characteristics of mutual funds.
  - 2.1 The master fund's name of the abrdn China Gateway Fund has been changed as follow;

2.2 The master fund's name of the abrdn Japan Opportunities Fund has been changed as follow;

The amendments to the fund schemes as per No. 2 are effective on 22 April 2022 onwards.

3. Updating the investment policy of the abrdn India Growth Fund (ABIG) and the abrdn Global Emerging Growth Fund (ABGEM) as per the Prospectus of their master fund. In addition, the master fund has disclosed promoting ESG approach in its investment policy as required by Article 8 of the Sustainable Finance Disclosure Regulation (SFDR) and is classified as 'Promoting ESG Fund', the regulatory measures in the EU for disclosure of the ESG characteristics of mutual funds.

The amendments to the fund schemes as per No. 3 are effective on 26 April 2022 onwards.
