- The Private Credit franchise has AUM GBP 10.5bn eqv.- testament to the depth of the team's relationships with industry contacts.
- 20 private credit specialists spread across US and UK.
- GBP7.3bn eqv. of private placements and infrastructure debt underwritten since inception across EUR, GBP and USD.
- In 2024, we activated the capability to provide YEN, AUD and CAD funding.
- A notable feature of 2023 deployment was 70% of production was in non-GBP transactions.

Private Placement and Infrastructure Debt Investment Criteria

- We are a relative value investor assessing pick up against public/ private comparable set in the currency of denomination and GBP eqv. term.
- Our investment funds are GBP denominated. We can provide swapped EUR, USD, YEN, AUD and CAD.
- Our focus is deploying into investment grade opportunities with a strong appetite for duration where we are able to invest out to as far as 40 years. For opportunities in the ultra-long end i.e. c.25 years+, we would prefer the rating outcome to be single A- or better.
- We can invest in unrated transactions provided we have the relevant methodology in place. We currently have 22 industry methodologies approved with the repository continuing to grow.
- We are very interested in structured/esoteric transactions and are happy to work with our agents in designing a bespoke structure that accommodates the needs and objectives of both issuer and our mandate requirements.
- As ever, ESG considerations remain integral to our investment process with annual targets set for sustainable investments for some accounts we manage.
- Necessarily, our range and depth of appetite continues to change over time so we will continue to keep you updated.
