





The abrdn Sustainable MPS and Sustainable Index MPS offer a comprehensive investment solution, each targeting five different levels of risk. They are built using best of breed sustainable funds from the whole of the market, including where appropriate, our own abrdn investment funds.

Four pillars: a clear and transparent approach



ESG integration

abrdn Sustainable MPS and abrdn Sustainable Index MPS invest in funds that include environmental, social and governance (ESG) factors in their assessment of the risks and opportunities of individual companies. By using this framework, fund managers gain a deeper understanding of companies' operations, allowing them to avoid companies with dubious business practices and invest in more sustainable businesses. We expect companies with sustainable business practices to outperform over time as they have stronger reputations, increased market share, increased profits and better revenue growth prospects.



Active stewardship and engagement

abrdn and the external fund managers invested within Sustainable MPS and Sustainable Index MPS portfolios use their influence to hold companies to account, to encourage positive behaviours and exercise voting rights on the issues that matter.



Avoiding harm

abrdn Sustainable MPS and abrdn Sustainable Index MPS invest in funds that actively aim to avoid controversial sectors or practices that are doing demonstrable harm to the environment and society, for example:

- Controversial weapons manufacturing.
- Companies that don't meet UN standards on human rights, labour, environment and anti-corruption (UN Global Compact).
- Tobacco production.

As well as avoiding companies that do harm, we use funds within the Sustainable MPS portfolios that invest in companies whose activities have a measurable positive impact on some of the most important issues facing the planet and society. These issues include areas such as climate change, poverty, sanitation, financial inclusion, access to clean water, hunger, among many others.
